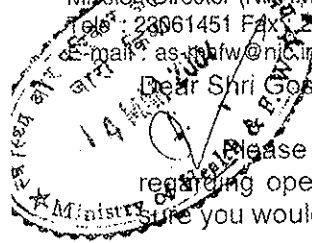

Dear Shri Goswami,  
Please refer to D.O. letter No Q.11011/1/2007-NRHM-II dated 23/27 February 2007 regarding operationalisation of the Community Monitoring Framework under NRHM. I am sure you would have started the process of setting up of committees at various levels.

You would recall that Advisory Group on Community Action is a standing group under NRHM mandated to spearhead the community related initiatives under NRHM. The Group comprises eminent representatives from major NGOs and meets regularly to hand hold activities relating to community action.

The members of AGCA under the overall stewardship of the Population Foundation of India (PFI) have been requested to assist in operationalisation of Community Monitoring initiatives in eight states (Assam, Chhattisgarh, Jharkhand, Madhya Pradesh, Maharashtra, Orissa, Rajasthan and Tamil Nadu) (in the first phase). The designated members of the AGCA shall be visiting the states and assisting in formation of the committees at various levels as well as orientation of the key members of the committees. The documentation, toolkits, guidelines as well as orientation material shall be prepared by the AGCA in consultation with the states and other stakeholders.

I take this opportunity to urge you to facilitate the operationalisation of the initiative and extend full cooperation to the teams from the AGCA. It would be advisable to designate a nodal officer in the state with whom the AGCA may coordinate for the initiative.

I look forward to your feedback on the progress of the initiative
