Sub: Sharing of Bank Account details for transfer of 15th FC recommended Health Sector Grants to City Health Societies / District Health Societies for utilisation of funds for the FY 2021-22.

Madam/Sir,

Inviting a reference to the subject cited above, I am directed to say that as per recommendation of State Level Committee (SLC) on 15th FC Health Sector Grant and instructions of the Health and Family Welfare Department vide UOI No.341 dated 03.12.2021, the grants for Urban Health and Wellness Centres (UHWCs) have been transferred to the 65 Nos. of Urban Local Bodies of the State for early utilisation. It is observed that the funds so released are still lying unutilised at ULBs level. As per the operational guidelines of the grant the funds to be utilised by the Urban Local Bodies in close coordination with the District Health Department under the overall supervision of the District Collector and utilisation certificate of the grant shall be submitted to this Department for onward transmission to Government of India for claiming the subsequent tranche of grant.

As per the decision taken in the last review meeting that the amount of Rs.89.19 crore released for Urban Health and Wellness Centres (UHWCs) to the different ULBs, is to be utilised by the City Health Societies and District Health Societies concerned immediately and utilisation certificate of the grant shall be submitted for claiming the grant for the FY 2022-23.

You are therefore requested to share the Bank Account details of the beneficiaries (City Health Societies and District Health Societies) and instruct the concerned Health Society for mapping of their account with PFMS under Scheme code " **OR151-Grants to Local Bodies -Urban recommended by 15th CFC**", by selecting the concerned Urban Local Bodies as funding agency to effect the transfer of funds through PFMS platform for utilisation at the earliest.
