Summary of experiences and difficulties

As a district coordinator of Dibrugarh district I have joined on 20th February 2016. Before my joining I have only a little knowledge about NHM so I was in a confused situation; whether I can perform the challenging role of District Coordinator or not. But after completing the 3 days training provided by NHM/VHAA/AGCA I have learn many important concepts which help me to think that, I can.

After taking the responsibility I had an informal meeting with the Block Facilitators of Dibrugarh District which helped us to introduced with each other and discuss about our work responsibilities. The team of Dibrugarh district is young, energetic and have willpower to do hard work. I have visited the Block PHC, District NHM office and other AWC/SC etc. and discussed about various health issues, problems etc. From my discussion with DCM of Dibrugarh I was able to understand that Naharoni Block of Dibrugarh is one of the most sensitive one. When I visited that particular block and discussed with ANM/ASHA I found that Naharoni is really a sensitive one.

In the field level the block facilitators and I have faced many problems. The main problem is the worst transportation facility.in some part of the villages is as remote as there is no road. Besides that some areas are covered by jungle where no public transportation facility available. Recently I have visited some area under khowang block where prior to our visit Tiger attacked 8 local people and they were hospitalized. So on that they we have visited that particular area with a deep fear in mind.

Although there is various problems in the field level one thing minimize all the problems i.e. the well behavior, well treat of the village people. When we visited the villages the people served us with a cup of tea. They treat us very well.
