SUMMARY REPORT OF SIVASAGAR DISTRICT

I, Chanakya Ranjan Neog have been appointed as the District coordinator of Sivasagar Dist on 20.02.2016 for the project Community Action for Health programme under Scorpion. My projected Dist. (Sivasagar) lies under Zone 5 and is conducted by Scorpion.

My area of operation: Jurisdiction under specified Block PHC, MPH/SD, S/C, VHS&NC Villages of the BPHCs in the SIVASAGAR district. I have successfully completed "State level TOT on Community Action for Health", organized by VHAA and NHM, Assam at NEDSF, Guwahati from 20.02.2016 to 22.02.2016. It was 3 days residential training programme. There are 8 Blocks and 8 Block facilitators under my projected District. These are Demow Block, Morabazar Block, Gaurisagar Block, Khelua Block, Geleki Block, Sapekhati Block, Kaloon goan Block and Patsaku Block.

Working procedure /Activates

According to the CAH project as a District Coordinator, I have to coordinate with Eight Block Facilitators for the success of the project. Each Block Facilitators have selected 40 VHSNCs and they have to work for strengthening of these allotted 40 nos. of VHSNCs.

We planned and also organized a Training programme with the help of SCORPION for Block Facilitators under zone 5 from 10th March -12th March 2016 at Hotel Ketekee in Dibrugarh.

After completion of training programme of Block Facilitators, the Block Facilitators started their field work related to strengthening of VHSNCs and I have given them support as asked by each Block Facilitators. These are some of the activities conducted by the Block Facilitators during the period 14.03.2016 to 31.03.2016.

1. Visit to Block PHC, Sub-Center, AWC, MPH for various work related to implementation of the CAH Project.
2. Meeting with ANM, ASHA supervisor, ASHA, BPM, BCM, SDM&HO etc. in purpose of the CAH project.
3. Attended meetings of 22 VHSNC, ASHA meeting etc.
4. Attended 3 nos. of VHND

Difficulties Faced

There is little difficulty faced by the Block Facilitators in field level. Such as- Block facilitator faced the difficulty for the cause of delay of work order.

We have seen that most of VHSNC meeting are irregular prior to the visit of Block Facilitators. Ward member were not interested to attend the VHSNC meeting.

SCORPION gives us a great opportunity for working with the Community Acton for Health. Team members of Scorpion are very active, sincere, and supportive so, progress actively of the CAH project. I got Positive response from the SDM&Hos, BPM, BCM of each BPHC. They assured the Block Facilitators of all support and co-operation from their end for successful implementation of the CAH progarrme in their respective.
